

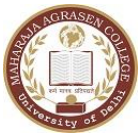

ELIGIBILITY CRITERIA

The following shall be the minimum eligibility criteria for selection of bidders/vendors at initial stage i.e. Expression of Interest (EOI). On the basis of the evaluation of E.O.I/Presentation with the qualifying vendors the further Bidding Process/Request for Proposal will be done in Single/Two Bid System as deemed fit.

1. The bidder should have experience of successful minimum **2 (Two)** similar projects of atleast **300 - 600 KW** Solar PV Power Plant of an Educational Institution/ Government Department/Organization/PSU/Societies. **(Please fill the Form III and copies of relevant contract/work order to be attached).**
2. The bidder's gross revenue from RESCO model during the last three financial years, i.e., **2021-22, 2020-21 and 2019-2020**, should not be less than **Rs. 2 Crore** (Rupees Two Crore) per year. A certificate to this effect from a Chartered Accountant should be submitted. **(Please fill the Form II and attach CA Certified Certificate and P&L Account ONLY).**
3. The project implemented should be in satisfactory working condition. A certificate (as on date) to this effect issued by the client is to be attached. **(Please fill the Form III and the copies of relevant documents).**
4. The bidder should attach a Certificate that the firm has not been blacklisted/debarred by any Educational Institution/Government Department/Organization/PSU/Societies.

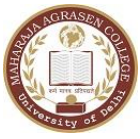
