Rehabilitation Council of India vide its notification dated 15th October 2020 have decided that the existing M.Phil. (Clinical Psychology) will continue without any change in its nomenclature or in the structure as these are professional training programmes in the area of mental health and rehabilitation.</p> <p>The Faculty after a detailed discussion agreed in principle that the existing M.Phil. (Clinical Psychology) programme at IHBAS may continue and the matter may be referred to the Research Council of the University for its consideration and thereafter the matter be placed before the Academic Council.</p>

No.DE-87(1)-2015 – In exercise of the powers conferred by Section 20 of the Dentists Act, 1948, the Dental Council of India, with the previous sanction of the Central Government, hereby makes the following Amendment to the existing principle Revised BDS Course Regulations, 2007, published in Part III, section 4 of the Gazette of India, Extraordinary, dated 10th September 2007:-

- Short title and commencement:-
 - These Regulations may be called the Revised BDS Course (7th Amendment) Regulations, 2015
 - They shall come into force on the date of their publication in the Official Gazette.
- In Revised BDS Course Regulations, 2007, the following insertion/modifications/deletions/substitutions, shall be as indicated therein:-
- In the existing Regulations under heading captioned as "EXAMINATIONS", sub-heading "SCHEME Examinations" and sub-heading "1 B.D.S. Examination:" the existing clause that "Any student who does not clear the 1st year BDS examination in all the subjects within 3 years from the date of admission shall be discharged from the course."

Substituted by the following clause that:-

"Any student who does not clear the BDS Course in all the subjects within a period of 9 years, including one year Compulsory Rotatory paid Internship from the date of admission shall be discharged from the course".
