1. The Committee **considered** the reply received from UGC and the letter No. Res.-2/A/9148 dated 22.09.2018 of Registrar, CCS University, Meerut on the issue. The Committee observed that the Registrar CCS University, Meerut has clarified that the CCS University is not awarding Ph.D degree in Law and instead awards LLD degree for which eligibility is LLM. Further UGC has clarified that as per its list LLD is a post doctoral degree for which eligibility is Ph.D. in Law.

After detailed deliberations and discussions, the committee **resolved** that in the light of the letter dated 22.09.2018 of the Registrar, Chaudhary Charan Singh University, Meerut it is established that CCS University Meerut is an University established by the state of U.P. through legislation in year 1965 and is an autonomous statutory body. Further, CCS University, Meerut has been awarding the degree of Doctor of Laws (LL.D) in lieu of degree of Doctor of Philosophy (Ph.D) in laws and the eligibility for admission in LLD degree is LLM which is similar to that for admission in Ph.D. (Law). Accordingly it was resolved that the LL.D. Degree issued by the CCS University to Mr. Siddharth Misra may be considered as equivalent to Ph.D. in Law.

2. The committee **considered** the request letter dated 08.08.2019 forwarded by the O.S.D. (Admission) case of Mr. Vinay. Mr. Vinay has done C.A. course and B.Com. from IGNOU University. He has done B.Com. with major in Accountancy and Finance exclusively for Chartered Accountants which is a course of one year. Accordingly his admission for M.Com. course is put on hold.

The Committee **resolved** that the Admission Committee of Faculty of Commerce may take decision based on the details of MoU by IGNOU and the fact whether the candidate is a certified Chartered Accountant CA by seeking clarification for the Indira Gandhi National Open University in this regard.

3. The committee **considered** the note dated 5th August, 2019 of FSR regarding directive on the eligibility of Mr. Shukurjon Gofurov, national from Uzbekistan to pursue B.A. (Hons.) English, 1st year in University of Delhi for 2019-2020.

The Committee **resolved** that in view of the letter of Association of Indian Universities the case of Mr. Shukurjon Gofurov cannot be approved. The FSR may inform the candidate accordingly.

The meeting ended with a vote of thanks to the Chair.
