NOTIFICATION

Subject: Guidelines/Policies related with grading/results for Intermediate Semester/Term/Year students for all UG and PG programmes all streams including NCWEB and SOL in view of the Covid-19 pandemic as one time measure for the academic session 2019-20.

This is in continuation of the notifications related with submission of marks of Internal Assessment, Practical examinations etc. issued on 13.05.2020 and Open Book Examination (OBE) to be adopted as an alternative mode of examinations by the University of Delhi in view of the COVID-19 pandemic for final semester/term/year students for the academic session 2019-20 as issued on 14.05.2020 and guidelines/policies applicable for the conduct of OBE for both UG as well as PG as issued by examination branch on 30.05.2020 and 01.06.2020 respectively.

In view of the prevailing situation of Covid-19 Pandemic, it is notified hereby to all concerned that the Intermediate semester/term/year students shall be graded with adopting alternative mode for the same as conducting examinations for Intermediate Semester/Term/Year students (second semester/term/ 1st year and fourth semester/term/IInd year students) in the conventional mode i.e. pen and paper is not feasible as per the existing government norms of maintaining social distancing and safety and health of the students. The matter was intensively deliberated in the bodies i.e. Task Force constituted by the University in view of Covid-19 and the Working Group on Examinations, based on which it has been decided that as one-time measure, alternative mode of grading for promotion/results shall be adopted as per composite format for calculating the same for the Intermediate semester/term/year students for the academic session 2019-2020 so that students of university can take their career forward.

- **Students of intermediate semester/term /year, the grading of the students could be composite of 50% marks on the basis of the pattern of internal evaluation/assignment based evaluation adopted by the university / colleges/ faculty/ centre wherever applicable and the remaining 50% marks can be awarded on the basis of performance in previous semester/term/year only .**

- For students of intermediate semester/term/year, having no previous performance i.e. having no marks in previous semester/term /year, shall be graded on the basis of 100% assignment based evaluation.

Procedures to be followed for Annual mode of examinations for UG students with reference to students of School of Open Learning (SOL) and Non Collegiate Women's Education Board (NCWEB) and others. Further procedure for 2nd semester (1st year) students of PG registered with SOL and NCWEB:

- 1) Grading of the second year students of UG and 2nd semester (1st Year) students of PG could be composite of 50% on the basis of the pattern of assignment based evaluation for students of Annual scheme and the remaining 50% marks shall be awarded on the basis of the performance in the previous semester/year. However, ex-students in the second year have to appear for examinations as per datesheet notified in OBE mode.
- 2) All these students are required to submit their assignment as per schedule notified by the SOL and NCWEB. Questions for assignment shall be from the courses of study based on syllabus applicable
- 3) The schedule, calendar and guidelines for the assignment based evaluation shall be decided by the SOL for the SOL students and by NCWEB for the students registered with the NCWEB. The calendar and guidelines for the students of PG registered with SOL and NCWEB should be released after due consultation with the Head of the respective departments.
- 4) All questions for assignment based evaluation shall be in bilingual wherever applicable
- 5) Students shall submit their assignment on the portal notified and communicated by SOL and NCWEB
- 6) Assignment by students shall be accepted within the defined period which shall be counted from the date of the delivery of question papers through e-mode on the e-address as per the record available to the office of SOL and NCWEB.
- 7) The decision to allow those students who could not submit their assignment as per the schedule notified shall be communicated by the beginning of August 2020 and accordingly all such left out students shall have to submit their examination forms to avail one more chance for the same
- 8) The matter of carry forward (for the subjects in which the student has failed in previous year) shall be allowed for the current academic year and every student shall be

promoted to the next year. However, such students shall be required to clear the examinations for the course in which he/she has failed/remained absent and carry forward papers, when examinations are held next year

9) All these students shall be allowed to improve their grades in succeeding year

Note: Ex-students of the first year and the Second Year of SOL and NCWEB have to appear in Open Book Examinations (OBE) mode as per the date sheet notified along with the Final year students applicable for SOL and NCWEB for academic session 2019-20 in view of COVID-19 pandemic.

For students of SOL of the First year under Semester scheme of examinations in CBCS mode of study for academic session 2019-20.

- 1) In the case of the first year students registered with SOL where examinations for both semesters are due and are to be conducted. In this situation, where previous semester marks are not available, there shall be 100% evaluation for grading based on assignment for both semesters simultaneously. All such students shall have to submit their assignment for the **First and the Second Semester as per the schedule notified and communicated by SOL accordingly.**
- 2) Students shall be graded based on the performance of the first semester and the second semester separately
- 3) All such results shall be prepared in grades as per CBCS rules applicable
- 4) Students who have arrears marked as Essential Repeat (ER) and those students who wish to improve their grades (in both cases) shall be allowed as per the cycle of the semester wherein course /papers for odd semester can only be attempted along with odd semester to be held in the month of January, 2021 and similarly courses/papers of even semester can be attempted along with the even semester to be held during months of May/June 2021

Note: All first and second year ex-students(UG and PG) of colleges and Departments, SOL and NCWEB shall appear in OBE mode as notified on 30.05.2020 and 01.06.2020 respectively as per date sheet notified for academic session 2019-20 along with the third year (final year) for UG and second year (final year) for PG.

All other relevant activities related with evaluation of internal assignments, practicals, field work, projects, dissertation shall be applicable as per notification issued by examination branch on 13.05.2020 and available on official website of university of Delhi. All relevant components shall be counted in the case of regular students/ex-students registered with colleges/centres/departments/faculties.

The University of Delhi in this difficult time endeavors to continue with the examinations related for the final year students and intermediate semester/term/year students as per datesheets notified so that our students can achieve their future goals.

Further, all concerned are hereby advised to be in touch with the official website of university of Delhi i.e. www.du.ac.in for updates related with examinations and their respective websites of college/departments/faculties /SOL/NCWEB.

Reference: Clarification on issue related with carry Forward for students appearing in examinations for assessment of Intermediate semester/term students for academic session 2019-20 as one time measure

This is in continuation with the notification issued on 04.06.2020 for intermediate semester/term/year students (I Year (II Semester/Term), II Year (IV Semester/Term)) UG and PG, **the following additions are required to be noted by all concerned** related with the grading and promotion for Intermediate semester/term/year students registered with colleges/departments/centres for academic session 2019 -20 as one time measure in view of COVID-19 pandemic:

1. **The matter of carry forward (for the subjects in which the student has failed) shall be allowed for the current academic year only and every student shall be promoted to the next year. However, such students may clear the examinations for the course in which he/she has failed/remained absent, when examinations are held next year as per the cycle of semester and the span period.**
2. All above students shall be allowed to improve their grades in the succeeding year as per the cycle of semester for students admitted in the semester mode of study .
3. For students admitted in the yearly mode of study, the notification issued on 04.06.2020 for students registered with SOL and NCWEB shall be applicable in the case of students belonging to yearly mode of assessment.

NOTIFICATION

In compliance of the order passed by the Hon'ble High Court on 14.07.2020 in W.P.(C) No.3199/2020 and in continuation to the notification issued on 08.07.2020 vide *Ref. No. Dean(Exams)/2020/updated* regarding the Open Book Examination(OBE) for the final semester/term/year students of all Undergraduate and Postgraduate courses including SOL and NCWEB to be conducted by the University, the following points may be noted by all concerned :

1. The University of Delhi shall conduct the examinations for the final semester/term/year students of all Undergraduate and Postgraduate courses including SOL and NCWEB from 10.08.2020 onwards in the OBE mode remotely. The examinations shall begin on 10.08.2020 and shall conclude on 31.08.2020.
2. The final date sheets for the Undergraduate courses shall be available on the official website of the University of Delhi (www.du.ac.in) by 16.07.2020. The datesheets for the Postgraduate courses and professional courses shall be released on the website by 22.07.2020.
3. For those students who for any reason are not able to appear in the examinations in OBE mode remotely which are scheduled to begin from 10.08.2020, the University has decided to conduct an additional phase of examinations in OBE mode through online/offline/blended mechanism as elaborated below:
 - This special dispensation is being made as a one-time measure for the convenience of such students who are unable to participate (wholly or in part) in the examination scheduled to begin on 10.08.2020 to provide them another opportunity to take their examinations, subject to the prevalent situation of COVID-19 and any further notification/guidelines from University Grants Commission (UGC).
 - The examinations will be conducted after about two weeks from the date of conclusion of the examination in OBE mode remotely.
 - The datesheets for these additional examinations shall be released in due compliance with the Standard Operating Procedure (SOP) for conduct of examinations as formulated by the MHRD and notified by the UGC vide Ref. No. D.O.No.F.1-1/2020 (Secy) dated 8th July, 2020.
 - The students under the PWD category including the visually impaired students who have appeared for the OBE remotely and who wish to improve their grades shall be given the opportunity to improve their grades in these examinations. The best grade/marks secured by the PWD students based on these two examinations shall be taken into

consideration for the preparation of results. (in compliance of the order dated 17.06.2020 passed by the Hon'ble High Court of Delhi in WP No. 3411/2020)

4. To make the examination process more seamless and smooth, the students, who has already filled their examination forms can see their information for their unique paper codes along with title of the examination papers, etc. The students who have never filled the examination form can fill the form through their dashboard. In case of any missing information or ambiguity, the students must inform their respective college through email (provided on the college website) to correct any errors in and/or to update their particulars such as mobile number, e-mail address, unique paper code etc. All the students are advised to access the examination portal from 21.07.2020 to 26.07.2020 and verify the correctness of their respective particulars.
5. The students who have not filled their examination forms due to any reason shall be given an opportunity to submit the same as per their respective scheme of examination and the span period. The students shall be given a time of four days beginning from 21.07.2020 and ending on 24.07.2020 to complete the process. The students are advised to enter the respective information and details of their respective papers carefully. The information as entered by the students will be automatically integrated with the examination portal, the colleges can verify the information received from students. **Students of regular colleges and NCWEB who have not submitted their examination forms are advised to submit their examination forms directly on the portal (<http://obe.du.ac.in>) latest by 24.07.2020. The students of SOL may update their examination forms at <http://solobe.du.ac.in>**
6. To rule out the possibility of any data entry errors in the examination forms, the portal shall also be made accessible to the college through a link so that the colleges can double check the details as entered by the students such as mobile no., e-mail address, unique paper code, description of papers etc. The process will start from **21.07.2020** till **26.07.2020**.
7. The Mock Test shall be conducted in two phases to make the students familiar with the procedure of OBE to be conducted remotely.
 - The *first phase* of the Mock Test will start from 27.07.2020 and will continue up to 29.07.2020. The tests will be conducted in three sessions each day. The schedule for the Mock Test will be notified by 24.07.2020.
 - The *second phase* of the Mock Test will begin from 01.08.2020 and will continue up to 04.08.2020. The second phase of mock tests will be based on real time and single paper of each program of final semester/year of undergraduate and postgraduate programmes of current batch. There will be three session of tests on each day. The session wise schedule of the Mock Tests will be notified by 28.07.2020.

8. The guidelines as issued on 30th May, 2020 and 1st June, 2020 related with the conduct of OBE for Undergraduate courses and Postgraduate courses respectively shall be applicable for the rescheduled examinations to be conducted as per the revised date sheet notified by the examination branch except at point nos. 16 and 17 respectively.
9. All the facilities extended to the students under the Divyaang (PWD) category in general and the Visually Impaired students in particular such as provision of study material/reference texts, assistive devices and the facility of scribe for the OBE shall continue to be applicable for the rescheduled examinations. **(Reference: Notifications issued on 04.06.2020, 22.06.2020 and 29.06.2020)**
10. Facilities available at college and departments of University will be made accessible to students belonging to PWD category in general and Visually Impaired (VI) in particular, so that ICT infrastructure is available to the students with the prior information during the schedule examination in OBE mode to be conducted remotely. The facility will be available to other students as well with prior information and with the conditions of adherence of guidelines of social distancing and safety measures.
11. As notified earlier, the facilities of ICT infrastructure to be provided to the students for the OBE at the Common Service Centre (CSC) engaged by the University shall be made available to the students for the rescheduled examinations also as per the new date sheet notified by the examination branch **(Reference: Notifications issued on 30.05.2020, 01.06.2020 and 22.06.2020)**
12. The procedure notified earlier on 02.07.2020 for downloading the question papers and uploading the scanned images of answer sheets for the OBE along with the details of the portal shall remain the same as before.
13. The provisions made for the redressal of grievances/queries of the students, if any, related with the OBE including those related with the date sheets shall remain the same as notified earlier by the Examination Branch **(Reference: Notifications issued on 19.06.2020 and 22.06.2020)**
14. The different guidelines as has been issued to the Deans/Heads/Principals of the Faculties/Departments/Colleges regarding the conduct of the OBE shall remain unchanged for the rescheduled examinations.

Reference: Additional facilities for students appearing in OBE mode remotely scheduled to be held from 10.08.2020.

In compliance of the order passed by Hon'ble High Court, Delhi on 07.08.2020 in W.P.(C) 3946/2020, the following arrangements/provisions are to be noted by all concerned as follows;

- 1) Students shall be given the complete three hours for answering the question papers. Additionally, all students are given one hour for scanning the answer sheets and for uploading the same. Students would have a total period of **Four hours** to complete the examination including down load question papers, scan and upload/email the answer sheets.
- 2) Students under PWD category are also given one additional hour for downloading the question paper, completing their answers and uploading the answer sheets i.e. a total duration of **Six hours**.

Students have the following options for uploading/emailing the answer scripts:

- 1) Students can scan the answer sheets page by page or question wise and upload the file on the portal of university within the **7 MB limit**;
- 2) Students can also convert their answer sheets into PDF files either question wise or in entirety and e-mail the same to the respective college/department/faculty email or only at central email address at obescript@exam.du.ac.in as defined in following points numbers 3 and 4.
- 3) Students must write their Roll Number, Unique Paper Code (UPC) and Date of Examination (dd/mm/yyyy) in the subject of their emails, e.g. Rollno-UPC-Date.
- 4) In the mail body student must write the following:

 - c) Name of Programme:
 - d) Unique Paper Code (UPC):
 - e) Title of the Paper (attempted):
 - f) Name of College:

- 5) Those students who upload the answer sheets on the portal would receive an acknowledgement.
- 6) In respect of students who email the answer sheets to the central email address as per point 2 mentioned above, shall receive auto generated acknowledging receipt.

Reference: Submission of Examination forms for OBE mode of examination to be conducted in blended (offline and online) mode and measures to be adopted during the second phase of examinations to be conducted w.e.f. 14.09.2020 for the final semester/term/year students in all Undergraduate and Post Graduate courses for the academic session 2019-20 as one time measure in view of COVID-19 pandemic.

The University of Delhi in compliance of the order passed by the Hon'ble High Court of Delhi on 14.07.2020 in W.P. (C) No. 3199/2020 decided to conduct the Open Book Examination (OBE) for the final semester/term/year students of all Undergraduate and Post Graduate courses including SOL and NCWEB as a one time measure in view of COVID-19 pandemic. The first phase of examination started on 10.08.2020 and will conclude on 31.08.2020.

The University in further compliance to the order passed by the Hon'ble High Court on 17.08.2020 in W.P. (C) No. 3199/2020 and 27.08.2020 will conduct the **second phase of examination** for the final semester/term/year students of UG and PG courses as one time measure in view of COVID-19 pandemic from **14.09.2020** onwards as per details provided below:

1. The second phase of examinations will be conducted for those students of Undergraduate and Post Graduate courses (Regular and ex-students) including SOL and NCWEB who have either not appeared or have failed to upload/submit the scanned images of the answer scripts in the first phase of examination.
2. Further, as already notified on 15.07.2020 the students under the PWD category who have appeared in the first phase of examination but wish to improve their performance in selected paper/s can appear for the same in the second phase of examinations. The best grade/marks secured by the student based on the two examinations shall be taken into consideration for the preparation of results.
3. The mode of examinations for the second phase of examinations shall also be *Open Book Examinations (OBE)* as adopted during the first phase of examinations conducted by university in the month of August, 2020.

4. Looking at the feasibility, the examinations for the second phase may be conducted in a blended (a mix of offline and online) mode. To facilitate those students who are outside Delhi and cannot travel to Delhi for appearing in the examinations for any reason, the University may conduct OBE remotely and such students can receive question paper to their registered e-mail and submit the scanned images /photos of the answer scripts to the e-mails as specified below at point no 16 and 17 of the notification.
5. Students who want to appear for the second phase of examinations shall be required to mention the option of the mode either the physical (offline) mode or remote mode using ICT based activities for receiving question papers and submission of answer scripts through e-mail in their examination form. Option once exercised by a student (offline/physical or ICT based remote examinations) appearing for the examination shall not be changed once the examination has begun.
6. Students who want to appear in OBE remotely shall have to select the required option and fill in the name of the programme with the option of papers and other relevant information in the examination form meant for the second phase of examinations.
7. Students who opt for the physical mode of OBE as per date sheet during the second phase shall have to appear at examination centres in Delhi only. The students shall appear at the particular examination centre as printed/mentioned on their admission ticket/admit card. Request for change of examination centre shall not be entertained by the University.
8. **In compliance of the order passed by the Hon'ble High Court on 27.08.2020 in W.P. (C) 3199/2020, the students under the PWD category including the Visually Impaired students who are residing at remote places and propose to travel to Delhi by train for sitting in the examination physically or through the online mode with the assistance of scribes shall indicate their preference at the specified column/space provided in the examination form for the second phase preferably before 04.09.2020.**
9. All students of the final semester/term/year for academic session 2019-20 including ex-students as per their span period and are appearing for the second phase of examination shall submit their examination forms using the student portal which shall be made available online from **30.08.2020**.
10. All particulars filled in by the student in the examination form will be verified by the respective college/department/faculty.
11. In case, if a student faces any problem in filling up the examination form he/she should contact the respective college/department/faculty for resolving the same.
12. The last date of submission of examination forms is **08.09.2020. No further date in this regard shall be extended.**

13. The date sheets for the second phase of examinations shall be notified on the official website of the University by the first week of September, 2020. There shall be two sessions in a day for all undergraduate programmes.
14. For all PG programmes, the respective department shall notify the date sheet and examinations shall also begin from 14.09.2020 and conclude on or before 03.10.2020.
15. The duration of the examinations for the offline/physical mode shall be of **three hours** duration and in case of the students who exercise the option to receive question papers through e-mail and submit the scanned images /photos of answer scripts through email the duration shall be of **four hours** which shall include one extra hour for using the ICT based activities for examinations.
16. The students under the PWD category who exercise the option to appear for the second phase of examinations in offline mode shall be given **five hours** for completion of examinations and if the students take the option to appear remotely and receive question papers through email and submit the answer scripts through email shall be given **one additional hour** for ICT based activities (as per order in the matter of W.P.(C) 3946/2020 dated 07.08.2020).
17. The students who exercise the option for the remote mode of OBE shall submit the scanned images/photos of the answer scripts on the e-mail addresses as given below:
 - i) For the students registered under regular courses with colleges/departments:

18. The students opting for the remote mode of examination using the ICT facilities shall follow the steps/instructions as specified below:
 - i) The subject of the e-mail must consist of: **Roll Number-Unique Paper Code (UPC)-Date of Examination (dd/mm/yyyy)**
 - ii) The body of the e-mail must provide the following information:
 - (a) Name of the student:

 - (f) Name of the College/Department:
 - (g) Semester:
 - (h) Date and Time of Examination: dd/mm/yy, Hrs: min

19. Students appearing in offline/physical mode of OBE in the college/department (as the name of examination centre indicated on admit card /admission ticket) shall submit their answer sheets in the physical form to the college/department after the completion of examinations.
20. The students for both the mode of examinations i.e. physical or ICT based activities shall answer the questions on plain/ruled A4 size paper and shall use their own papers for writing their answers. All particulars i.e. examination roll no , UPC , semester, name of the subject , date of examinations, page no on each paper etc should be clearly mentioned on the top page .
21. There will be no physical assistance during examinations in the college and departments. Therefore, all arrangements made by the college /department for physical examination shall be adhered following the norm of social distancing and seating arrangements have to be strictly as per SOP /guidelines as issued by UGC dated 06.07.2020 (copy enclosed) .
22. As per SOP in the reference, all security and safety measures have to be adhered by all students and concerned staff members during examinations. Accordingly, students shall take appropriate safety measures while appearing for physical mode of examinations at the college/department level and carry all required items i.e face mask , hand sanitizer etc .
23. All required stationary to be used for examinations shall have to be arranged by students for examinations.
24. All electronic gazettes shall be permissible during examinations. Question papers may be sent on the WhatsApp or email during examinations instead of printed paper. However, students can submit their request to get the physical question paper for examinations to the college/department as per datesheet.

Further all relevant updates/information regarding the second phase of examinations will be available on the official website of the University i.e. www.du.ac.in in due course of time. No separate email or information shall be sent to individual student in this regard.

Note :

- 1) **Information related with OBE mode for the second phase of examinations of any or any addition/modifications related with procedures or policies of OBE mode to be conducted for the second phase shall only be notified on the official website of the university i.e www.du.ac.in .**
- 2) **Students are advised to be in contact with their respective colleges/departments for specific updates related with the second phase of OBE .**
- 3) **Above guidelines /measures are valid only for final semester/term/year students who have not appeared for the first phase of OBE mode of examinations as**

conducted remotely or could not submit their answer scripts through email for any reason except students belonging to PWD category who are allowed to appear for the second phase of OBE mode of examinations.

- 4) Students shall be allowed for the second phase of examination based on the submission of their examination forms and the mode opted in the examination form.

Subject: Promotion Criteria for the Intermediate Semester/Year students of Undergraduate and Post Graduate courses (except Council Mandatory Courses) in all streams including Non-Collegiate Women's Education Board (NCWEB) and School of Open Learning (SOL) as one time measure for the current academic session 2019-20 in view of COVID-19 pandemic.

In the light of the 'Guidelines on Examinations and Academic Calendar for the Universities in view of COVID-19 Pandemic and subsequent lockdown' issued by the University Grants Commission on 29.04.2020 and the subsequent notifications issued by the Examination Branch on 04.06.2020 and 08.06.2020, it is notified for information to all concerned that the following promotion criteria shall be adopted for the Intermediate Semester/Year students of Undergraduate and Post Graduate courses registered with the regular colleges/departments, Non-Collegiate Women's Education Board (NCWEB) and School of Open Learning (SOL) as one time measure for the current academic session 2019-20 in view of COVID-19 pandemic:

The students shall be allowed to carry forward the subjects in which he/she has failed in a semester/year and shall be promoted to the next year. However, such students may clear the examination for the course in which he/she has failed/remained absent, when examinations are held next year as per the cycle of semester and the span period.

The above promotion criteria shall be applicable for-

- i) The students of II Semester (Part I) or IV Semester (Part II) Examination of Undergraduate and Post Graduate Courses.
- ii) The students of II Year Undergraduate courses under Annual Mode and II Semester (I Year) Post Graduate Courses registered with the School of Open Learning and Non-Collegiate Women's Education Board (NCWEB)
- iii) The students of First Year of Undergraduate courses under the Choice Based Credit System (CBCS) of School of Open Learning.

NOTE: i) The above provision is applicable only for the current academic session (2019-20) in view of COVID-19 pandemic.

ii) The above provision shall not be applicable for the courses administered by the Statutory Regulatory Bodies/Councils.
