TO BE PLACED AS AGENDA ITEM BEFORE THE ACADEMIC COUNCIL MEETING.

It is requested that the following Agenda Item may kindly be placed before the forthcoming AC meeting of University of Delhi.

**"Online Green Case Materials" only to LL.B and LL.M students of Faculty of Law and consequent waiver of fees.**

It has been unanimously decided in the meetings of Committee of Courses and Studies in Law; and Faculty of Law, both held on 5th November, 2020 that Faculty of Law should provide Online Case Materials only to the LL. B and LL.M students and the fees charged for the printed copies (Rs 1000/- Per semester in case of LL.B students and Rs1250/- in case of LL. M students) should be waived off entirely.

This decision is necessitated due to the following reasons—

1. All classes of LL.B and LL.M are going online as well as the access to the library facilities is also provided 'online' by the University. More so the masses of students, by and large, prefer to use the digital resources due to the ease in universal accessibility, by using the internet from anywhere in the country.

In any case, if any student wants and requires, he can always download the whole material or a part of it and get it printed himself, in the manner (size/font etc.) he likes.

Thus, the online case materials are energy savers, as well as provide better practical choices to the students.

2. Online case materials are an important step towards advancing and enhancing the approach of "go GREEN" as those are environment friendly as the precious paper is saved.

3. In times of corona pandemic, it is strategically a better choice to provide the case materials online only and waiving off the concerned fees.

In the last semester of Jan-April, 2020, extreme hardship was posed to the office to complete the tender formalities due to closures resultant to national lockdown, and consequently delay was caused and the distribution of case materials could not be started at all for 2-3 months due to national lockdown.

4. As on date, the University is still closed for students making the distribution of case materials much difficult; and the case materials of the last semester are still kept and are occupying a large space in all three centers so there is a lot of space problem also for the storage of case materials.

Practically no storage spaces are available in the Faculty of Law where case materials of the next semester can be kept.

Keeping all these factors in mind, it is very desirable to provide LL.B. & LL.M case materials Online only; to be uploaded on the website of the Faculty of Law; and the case material fees for it, be completely waived off.
