### **1. CONFIRMATION OF MINUTES OF THE FINANCE COMMITTEE MEETING HELD ON 7<sup>th</sup> July, 2017.**

**2. TO CONSIDER THE BUILDING PROJECT PROPOSALS DULY FINALIZED AND RECOMMENDED BY THE BUILDING COMMITTEE**

The project proposals duly finalized and recommended by the Building Committee in its meetings held on 31.10.2017/7.11.2017 and 13.12.2017 as per APPENDIX- B of the agenda item were placed before the Finance Committee.

As recommended by the Building Committee, the Finance Committee decided to change the name of work to "Repair and maintenance at Keshavpuram" and advised to communicate the same to U.G.C. after approval of the Executive Council.

The Comments of the UGC and MHRD vide email dated 25<sup>th</sup> January 2018, 19<sup>th</sup> January and 24<sup>th</sup> January 2018 respectively on the agenda items were taken on record of the Finance Committee. In view of the UGC's comments vide e-mail dated 25.1.2018, regarding re-appropriation/allocation of funds for the University Building projects, the matter was deliberated in detail in the FC meeting. The Committee further emphasized that there is a genuine requirement of funds for various building projects including construction of girls' hostel, law faculty building etc for efficient functioning of the University.

The Finance Committee considered the above Building Project proposals and accepted the proposals "in-principle". The Committee also recommended the same for the approval of the Executive Council subject to the following:

- i. Each project is fully funded and the entire funds have been allocated and released by the UGC for each individual project;
- ii. No additionality will be sought from MHRD/UGC for the projects. Further no part of the internal receipts, UGC/MHRD grants including interest accrued on each such grant will be utilized for CAPEX; and
- iii. Abstract of Cost and Rate Conformity certificate as also other related codal formalities for each Building Project are strictly as per relevant UGC guidelines. Further, award of "Civil Works" is strictly as per the relevant provisions of GFRs, 2017 and related CVC guidelines.

The committee further recommended that the University may take up the matter with the UGC for approval of the Standing Committee of the UGC, wherever applicable, as per UGC guidelines and for approval and allocation of funds for the proposed Building Projects after the approval of the Executive Council.

**3. ANY OTHER ITEM**

The proposal regarding creation of post of the Director, North Campus alongwith detailed justification was placed before the Finance Committee. The matter was deliberated at length and the Finance Committee accepted the proposal "in-principle" and recommended the same for the approval of the Executive Council for the creation of the post of Director, North Campus subject to the following conditions:

- a) that there shall be no financial implication as the post will be filled from amongst serving Professor (s) of University of Delhi;
- b) that the necessary amendments/additions to the Statutes be made by the University with the approval of the competent authority; and
- c) that the proposal in this regard may be forwarded to the Visitor through MHRD.

The meeting ended with a vote of thanks to the Chair.
