Sir/ Madam,

This Office is in receipt of a letter from the Office of the Director General of Audit, (Central Expenditure) expressing delay in submission of Annual Accounts for the Financial Year 2013-14 and 2014-15, a copy of which is enclosed for your information.

- 2. In this context, it is to inform that non-submission of Annual Accounts within the target date results in not only delay in receipt of Separate Audit Report (SAR) but also delay in submission of Annual Accounts to the Parliament, which has been viewed seriously by the Ministry of Human Resources & Development and University Grants Commission (UGC).
- 3. The implementation of new formats of Accounting and Financial reporting for Annual Accounts preparation available on UGC website i.e. www.ugc.ac.in, is a mandate for the current Financial Year 2015-16.
- 4. It may be ensured that the duly approved Annual Accounts for Financial Year 2015-16 may be submitted within the prescribed time i.e. 31.05.2016. The progress on closing of Accounts as per the time schedule of Closing of Accounts, as directed by MHRD/DGA (CE) may be submitted to the University.
