Biography

Gerald L. Neuman is the J. Sinclair Armstrong Professor of International, Foreign, and Comparative Law, and the Co-Director of the Human Rights Program at HLS. He teaches human rights, constitutional law, and immigration and nationality law. His current research focuses on international human rights bodies, transnational dimensions of constitutionalism, and rights of foreign nationals. He is the author of Strangers to the Constitution: Immigrants, Borders and Fundamental Law (Princeton 1996), and co-author of the casebook Human Rights (with Louis Henkin et al., Foundation Press). Prior to joining HLS in 2006, he served on the faculties of the University of Pennsylvania Law School (1984-1992) and Columbia Law School (1992-2006). From 2011 to 2014, he was a member of the Human Rights Committee, the treaty body that monitors compliance with the International Covenant on Civil and Political Rights.

Biography

Dan Sarooshi QC is Professor of Public International Law in the University of Oxford and Senior Research Fellow of the Queen's College, Oxford. He joined the Oxford Law Faculty and The Queen's College in 2003. His authored books have been awarded the American Society of International Law (ASIL) Certificate of Merit (twice); the Myres S. McDougal Prize by the American Society for the Policy Sciences; and the (biennial) Guggenheim Prize by the Swiss Guggenheim Foundation. He has authored over 50 shorter academic pieces, including the 125 pp. co-authored chapter with Judge Dame Rosalyn Higgins DBE, QC, and Dr P. Webb, "Institutional Modes of Conflict Management"; and he is currently co-authoring and co-editing with Judge Sir Christopher Greenwood GBE, QC, the classic work *Oppenheim's International Law: Vol. 1 Peace* (OUP, 10th ed.) (in preparation).

He was appointed by the World Trade Organization in 2006 to the WTO Dispute Settlement List of Panellists (jointly nominated by HMG/EU). He practises as a Barrister (Queen's Counsel) from Essex Court Chambers, London. He was elected in 2008 to membership of the Executive Council of ASIL and elected as an ASIL Counsellor in 2018.

He delivered from 23-27 July 2018 the Hague Academy of International Law Lectures on "The Immunities of States and International Organizations in Domestic Courts"; and served previously as Director of the Hague Academy's Centre for Research in International Law and International Relations (English and French Sections), 2011 and as Director of Studies for Taught Courses of the Hague Academy in 2005.

Six of his former DPhil supervisees have had a revised version of their thesis published as a monograph by leading academic publishers.

BRIEF BIO

Raj is the inaugural Leo. S. Brenneisen Distinguished Professor (2017-present) at the University of Kansas School of Law, before which he held the inaugural Rice Distinguished Professorship (2003-2017). Both are university-level chairs, the highest accolade for scholarship and research in Kansas. He has served as KU's Associate Dean for International and Comparative Law (2011-2017).

Raj practiced at the Federal Reserve Bank of New York, where he twice won the President's Award for Excellence, thanks to his service as a delegate to the United Nations Conference on International Trade Law. He is Senior Advisor to Dentons U.S. LLP, the world's largest law firm, focusing on international and comparative legal matters.

A Harvard Law School graduate, he completed Masters degrees at LSE and Oxford as a Marshall Scholar, and an undergraduate degree at Duke as an Angier B. Duke Scholar.

Raj is author of one of the world's leading textbooks in international trade law, International Trade Law: A Comprehensive Textbook, and the first treatise on GATT in nearly 50 years, Modern GATT Law. He is the first non-Muslim American scholar to write a textbook on Islamic Law, Understanding Islamic Law (Sharī'a). His newest book is on the Trans Pacific Partnership, TPP Objectively. His current book projects Principles of Law, Literature, and Rhetoric and Business Law of Modern India. "On Point" is his monthly column, which BloombergQuint (India) publishes (www.bloombergquint.com).

He is an avid distance runner and has completed three of the "World's Major Marathons" (Boston twice, Chicago, and New York), and is a student of Shakespeare and Hindi.
