The Executive Council observed that the plea of inadvertent lapses taken by Dr. Supriya K. Kar does not mean admission of the alleged misconduct. Submission of fake bills to the University is a serious matter.

The Executive Council decided that a Show Cause notice may be issued to him pointing out that submission of fake bills to the University and making entries in the records/stock register of the University based on the fake bills are acts of serious misconduct involving moral turpitude warranting action under Clause 6 of the Annexure to Ordinance-XI of the University, as they cannot be regarded as inadvertent lapses as alleged by him. He be directed to submit his reply within 21 days from the date of issue of Show Cause notice, failing which matter will be proceeded further as per the rules of the University.

- "Letter No. F.No.6-5/2017(SCT) dated 3/7th April 2017 and MHRD letter F.No. II. 11-4/2017-SC/ST dated 30.01.2017 & letter No. F.19-9/2017-CU.Cdn dated 13.02.2017 and Ministry of Social Justice & Empowerment O.M. dated 06.01.2017 regarding a copy of Gazette Notification of the Rights of Persons with Disabilities Act, 2016 as placed at Appendix-XCIV.
- To report the MHRD directives issued vide letter No. F.No.32/2016-CU-II dated III. 23rd May 2017 in connection with filing of Special Leave Petitions against the Judgment of Division Bench of Hon'ble High Court of Delhi dated 24.08.2016 passed in the matters relating to CPF - GPF. The details concerning the matter are as under:
  - The Executive Council of the University on 28.02.2017/07.03.2017 1. considered the recommendations of Task Force constituted by the Vice-Chancellor, chaired by Treasurer, [University of Delhi to examine the directive of MHRD vide letter No. F.4-41/2014-Desk(U) dated 23rd January 2017. The Task Force recommended to implement the Division Bench Judgment dated 24.8.2016 in respect of Category - I (N.K. Bakshi batch) and Category-III (Virmani batch) and file an appeal (SLP) in the Apex Court in respect of Category - II (Shashi Kiran batch). The Executive Council approved the recommendations of the Task Force duly accepted by the Finance Committee at its meeting held on 20.2.2017.
  - While the draft SLP in respect of Category II (Shashi Kiran batch) sent to 2. the Ministry for observation, the MHRD vide its letter No. F.No. 4-9/2017-CU.II dated 21st April 2017 (Appendix-XCV) observed that SLP is to be filed in all those cases where an employee who was in service as on 1.1.1986, had specifically chosen to stay with CPF whereas, the University proposes to file SLP in respect of "Shashi Kiran batch" only. Further states that the "N.C. Bakshi batch (Category-I) also chose to stay with CPF, though within the extended period of option beyond 30.9.1987 upto 28.2.1988. But, no SLP is filed in such cases. Executive Council in its emergent meeting held on 29th April 2017 noted the MHRD letter No. F.No.4-9/2017-CU.II dated 21st April 2017 and resolved to file the SLP in the Hon'ble Supreme Court of India against orders dated 24th August 2016 of Division Bench of the Hon'ble High Court of Delhi.
