EXAMINATION - IV

A committee was constituted by the Competent Authority to finalize the draft of degree including Ph.D. degree to be awarded in the 93rd Annual Convocation of the University of Delhi. (Flag 'A')

The committee under the Chairmanship of Prof. V.K. Chaudhary, Department of Biochemistry, met on 8th, 10th and 16th August, 2016 in the committee room of the Dean (Examinations) to finalize the draft of the proposed format of degree. (Flag 'B', 'C' and 'D')

The committee examined different types of format of degree provided by the printer presently engaged for the degree printing work of the University of Delhi. Further, clarification was also sought from the Council Branch regarding the format of degree and the official logo used on the degree. The Council Branch in clarification, forwarded a copy of the E.C. Resolution No. 76 dated 26.06.2009 wherein it was resolved that the Hindi Version of "University of Delhi" which was adopted vide E.C. Resolution No. 326 dated 02.11.1968 shall be continued in the University Seal (Flag 'E'). However, it was informed by the Council Branch, no resolution/regulations regarding format of Degree is available in their records. (Flag 'F')

The committee based on the inputs as above and after much deliberation decided upon the new version of degree which shall be conferred to the students from the forthcoming 93rd Annual Convocation of University of Delhi after approval in due process. A copy of the minutes of the meeting is enclosed at (Flag 'I')

The new version of the degree (Flag 'H') shall comprise of the following features:

- i) White base for the degree
- ii) Purple colour logo inscribed with Hindi version of 'University of Delhi' (Flag 'G')
- iii) Yellow images of the official logo printed at either side of 'University of Delhi' which would remain invisible in final offset security printed output.
- iv) Security features as is being applied in the present degree shall be integrated in the new version.

The committee however, resolved that the new version of degree with a white base and the changes in the official logo as recommended at point no. (ii) above shall be adopted only through a detailed process with the prior approval from the competent authority and subsequently the approval of the Academic Council and the Executive Council or through the emergency power of the Hon'ble Vice Chancellor.

Following is also submitted for consideration:

- (a) 235 degree certificates have already been issued in Advance of 93rd Annual Convocation in the existing format. It is for consideration if degree certificates are to be issued in two different formats in a year.
- (b) Regulation regarding Convocation needs to be re-visited to bring it in conformity with practice and to include proposed and other changes as well.
- (c) Design of seal may be described in detail with the help of design professionals.
- (d) A vendor is to be engaged to prepare degree certificate in new design.
- (e) MHRD/UGC has initiated to have a system electronic depository of academic qualifications. New degree format may be designed to integrate with depository.
- (f) Mentioning of Ph.D. thesis title on degree certificate was discontinued w.e.f. 14/03/12. It is for consideration whether practice may continue or it is to be re-considered.

The committee during the meetings deliberated on the various aspects of the new degree matter and put forth the following recommendations:

1. The committee resolved that the colour of the University Flag shall be purple as per the description of the University Flag approved vide the A.C. Resolution No. 302 dated 11.01.1962 and E.C. Resolution No. 3703 (15) dated 27.01.1962 (**Flag 'E'**).

Further, in the year 1968, as per E.C. Resolution No. 326 dated 02.11.1968, the Council adopted to inscribe in the University Seal, the Hindi equivalent of 'University of Delhi'. (Flag 'E').

A note was sent to the Joint Registrar (Council) to provide resolution/regulation regarding the format of Degree and the official logo to be used on the degree. However, the note was returned back by the Joint Registrar (Council) with the remarks that no resolution/regulations regarding format of Degree is available in their records. (Flag 'F')

The committee thus resolved that the logo with the Hindi version as approved by E.C. Resolution No. 326 dated 02.11.1968 may be taken on records.

2. The committee requested Prof. Sanjay Kapoor (Department of Plant Molecular Biology), who had earlier prepared the University logo with purple colour, to propose an alternate logo having Hindi version along with the possible revised formats of the Degree. The committee appreciated the efforts of Prof. Kapoor for the same.
3. An alternate logo with purple colour along with the Hindi version is also attached as deliberated by the Committee (Flag 'G').
4. The Committee resolved that the new version of the degree as recommended by the committee shall be integrated with all the security features as applied in the present degree (Flag 'H').
5. The committee also resolved that changes if any are to be made in the official logo of the University printed on the degree shall be done only through a detailed process with the prior approval from the competent authority and subsequently the approval of the Academic Council and the Executive Council shall also be taken or through emergency power of the Hon'ble Vice Chancellor.
6. The committee further resolved that the new version of degree may be conferred to the students from the forthcoming 93rd Annual Convocation of University of Delhi.

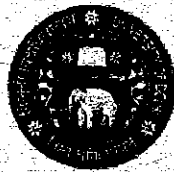

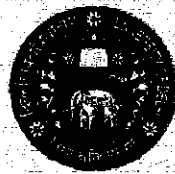
