**7/-** The Executive Council considered the recommendations of the Committee constituted by the University consisting of the Dean, Faculty of Science, Dean, Faculty of Arts and Dean, Faculty of Law made in its meeting held on 12<sup>th</sup> May, 2017 regarding withdrawal of LL.B. degree of the University of Delhi, awarded to Mr. Aashish Kumar Gupta S/o Durga Prasad by the University in the year 2011-2014 vide Roll No. 118002, in pursuance of the provision Statute 15 of the Statutes of the University of Delhi.

Mr. Aashish Kumar Gupta Pursued MBA (Master of Business Administration) regular degree from Guru Gobind Singh Indraprastha University (GGSIPU) University, Delhi during the academic session 2010-2012 while pursuing the LL.B. 03 years degree from the Law Centre-II, Faculty of Law, University of Delhi in the year 2011-2014 which is in violation of the Academic Council Resolution No. 40 dated 24.04.1997 and Resolution No. 49 dated 14.05.1975.

As per Statute 15, “*the University Court may, on the recommendation of the Executive Council, by a resolution passed with the concurrence of not less than two-thirds of the members voting, withdraw any degree or diploma conferred by the University*”.

The Council recommended the withdrawal of LLB Degree of the University of Delhi awarded to Shri Aashish Kumar Gupta S/o Durga Prasad by the University in the year 2011-2014 vide Roll No. 118002 to the University Court for approval.
