

Subject: Extension of orders of Dearness Allowance issued by Department of Expenditure for employees of the Central Government/ Autonomous Bodies who are in pre-revised scale of 6th CPC for grant of Dearness Relief to Pensioners of the Central Autonomous Bodies who are drawing pre-revised pension as per 6th CPC.

Vide D. O. letter No.1/2/2017-E-II(B) dated 26th October, 2017(copy enclosed), D/o Expenditure has authorized Financial Advisers(FAs) of the Ministries/Departments to extend the orders of Dearness Allowance issued by Department of Expenditure for employees of the Central Government/ Autonomous Bodies who are in pre-revised scale of 6th CPC for grant of Dearness Relief to Pensioners of the Central Autonomous Bodies who are drawing pre-revised pension as per 6th CPC.


2. Vide D/o Expenditure O.M. No.1/3/2008-E.II(B) dated 9th November, 2016, 7th April, 2017 and 26th September, 2017, Dearness Allowance of the employees of the Central Government and the Central Autonomous Bodies drawing their pay in the pre-revised pay scale/grade pay as per 6th CPC has been revised from 125% to 132% w.e.f. 1.7.2016, from 132% to 136% w.e.f. 1.1.2017 and from 136% to 139% w.e.f. 1.7.2017.

3. Accordingly, Dearness Relief of the pensioners of Central Autonomous Bodies under the administrative control of Ministry of Human Resource Development drawing pre-revised pension as per 6th CPC may be revised from 125% to 132% w.e.f. 1.7.2016, from 132% to 136% w.e.f. 1.1.2017 and from 136% to 139% w.e.f. 1.7.2017.

OFFICE MEMORANDUM

Subject:- **Rate of Dearness Allowance applicable w.e.f.1.7.2016 to employees of Central Government and Central Autonomous Bodies continuing to draw their pay in the pre-revised pay scale/grade pay as per 6th Central Pay Commission**

Consequent upon acceptance of the recommendations of the Seventh Central Pay Commission by the Government, this Department vide O.M.No. 1/2/2016-E.II(B) dated 4th November, 2016 had issued orders on rate of Dearness Allowance (DA) payable to Central Government employees based on the revised pay structure that came into effect from 01.01.2016.


2. The above rate, however, is not applicable to those Central Government employees who had exercised an option to continue in the pre-revised scales of pay based on 6th CPC's recommendations or to those whose pay and allowances had not been revised, for different reasons.

3. Further, as the recommendations of 7th CPC have not been made applicable to the employees of Central Autonomous Bodies as of now, they continue to draw their pay in the pre-revised pay band/grade pay as per 6th CPC recommendations. Therefore, the above rate of DA is also not applicable to these employees also.

4. The rate of DA w.e.f.01.01.2016 for Central Government employees and employees of Central Autonomous Bodies in pre-revised scale of pay, were issued by Department of Expenditure vide O.M.No. 1/1/2016-E.II(B) dated 7th April, 2016.

5. Accordingly, the rate of DA admissible to employees of Central Government and Central Autonomous Bodies who continue to draw their pay in the pre-revised pay band/grade pay as per 6th CPC recommendations, shall be enhanced from the existing 125% to 132% w.e.f.01.07.2016.

6. The contents of this Office Memorandum may also be brought to the notice of the Organisations under the administrative control of the Ministries/Departments which have adopted the Central Government scales of pay.


Subject:- **Rate of Dearness Allowance applicable w.e.f.1.1.2017 to employees of Central Government and Central Autonomous Bodies continuing to draw their pay in the pre-revised pay scale/grade pay as per 6th Central Pay Commission**

The undersigned is directed to refer to this Department's O.M.of even No. dated 9th November, 2016 revising the rates of Dearness Allowance w.e.f.01.07.2016 in respect of employees of Central Government and Central Autonomous Bodies continuing to draw their pay in the pre-revised pay scale/grade pay **as per 6th Central Pay Commission.**

2. The rate of DA admissible to above categories of employees of Central Government and Central Autonomous Bodies shall be enhanced from the existing rate of **132% to 136% w.e.f.1.1.2017.**

3. The provisions contained in paras 3,4 and 5 of this Ministry's O.M.No. 1(3)/2008-E.II(B) dated 29th August, 2008 shall continue to be applicable while regulating Dearness Allowance under these orders.

4. The contents of this Office Memorandum may also be brought to the notice of all organisations under the administrative control of the Ministries/Departments which have adopted the Central Government scales of pay.

Dear Sir/Madam,

References have been received in Department of Expenditure seeking clarification on grant of Dearness Relief (DR) to the Pensioners/Family Pensioners of Central Autonomous Bodies who are in receipt of pension in pre-revised pay structure/scales of 6th CPC.

2. Department of Expenditure issues orders for Dearness Allowance in respect of Central Govt. employees who are in revised pay scale and also issues orders in respect of Central Govt. employees / Central Autonomous Bodies employees who are in the pre-revised pay scale. Department of Pension & Pensioners Welfare (DoP&PW) issues orders in respect of Pensioners.

3. After implementation of 7th CPC, D/o Expenditure issued orders for rates of DA w.e.f. 01.07.2016, 01.01.2017 and 01.07.2017 in respect of Central Govt. employees who are in revised pay structure of 7th CPC as well as in respect of Central Govt. employees / Central Autonomous Bodies' employees who are in pre-revised scale of 6th CPC. Department of Pensions & Pensioners Welfare (DoP&PW) issued orders only in r/o Central Govt. pensioners who are in revised pension as per 7th CPC. However, it has come to notice that no orders have been issued for DR for pensioners of Central Autonomous Bodies who are in pre-revised pension as per 6th CPC.

4. The matter has been considered in this Department. To resolve the hardship being faced by the pensioners of Central Autonomous Bodies, FAs of the Ministries/Departments are advised to extend the orders of DA issued by this Department for Central Govt. employees/Central Autonomous Bodies' employees who are in pre-revised scale of 6th CPC, for grant of DR to pensioners of the Central Autonomous Bodies who are in pre-revised pension as per 6th CPC, under their administrative control.

5. This issues with the approval of Finance Secretary.
